Substitution requests are required in writing from the original attendee before a review can commence; there is no additional charge for a substitution.

Attendees are not permitted to share a registration.

Cancellation/Refund Policy

Refund requests must be received in writing to kcampbell@orkaevents.com.au and eligibility for a refund will be based on the following criteria:

- Requests received 21 business days prior to the event are entitled to a full refund less the administration fee of \$50.00.
- Requests received 14-20 business days prior to the event are entitled to a 50% refund less the administration fee of \$50.00.
- Requests received less than 14 business days prior to the event shall not be entitled to a refund or credit note.

Refunds will be processed using the same method originally used to pay for your purchase.

Cancellation due to COVID-19

In the event of an outbreak of COVID-19, AMA (NSW) reserves the right to cancel the event, if this occurs then your registration will be refunded in full using the same method originally used to pay for your purchase.

Postponement due to COVID-19

If the event is postponed due to an outbreak of COVID-19, attendees will be notified immediately and offered to transfer their original ticket to the new date.
If the new date is not suitable, a full refund will be offered.
